While the past year - our third year of living and coping with the COVID-19 pandemic - has been challenging, HPCO continued to focus on the needs of members. Some of our achievements this past year include:

- Continued advocacy for more sustainable and expanded hospice funding including: equitable funding for Visiting Hospice Services; enhanced funding for grief, bereavement, and psychosocial supports in all hospices; increased funding for hospice residences through a change in the funding formula to a more equitable percentage-based model that funds 100% of clinical care; and, Health human resources retention measures, including competitive wages and benefits.
- The return to an in-person annual conference in April with over 600 delegates attending. 96% of delegates said that the conference met or exceeded their expectations and 91.3% said the education and information they received will help initiate positive change in their practice.

As we continue to navigate the challenges of the COVID-19 pandemic, we are excited to announce that the <u>2023</u> <u>HPCO conference</u> will once again be in person from June 11 - 13, 2023. We look forward to engaging with you and the conference theme - **Now is the Time for Hospice Palliative Care**.
