

Accreditation Fee Schedule Effective April 1, 2025

The HPCO Accreditation Program operates on a three-year cycle. The cost of the program is partially covered by fees paid by the participating organization. Accreditation Fees are non-refundable with the exception of the Appeal Fee being refunded as outlined in the Accreditation Manual. An updated Fee Schedule will be posted to the HPCO website annually by February 1.

The Accreditation Fee Schedule that is in place at the time of Registration will be guaranteed for the remainder of the 3-year cycle *if the organization completes the Application within one year of registering*. The Fee Schedule may change between Registration and Application if not completed within one year.
